Eindhoven, The Netherlands, September 7, 2012 - NXP Semiconductors N.V. (NASDAQ: NXPI) announced today that its subsidiary, NXP B.V., together with NXP Funding LLC, has filed notices for the redemption of \$199,779,000 aggregate principal amount of its outstanding U.S. Dollar-denominated 10% Super Priority Notes due 2013 and €1,436,000 of its outstanding Euro-denominated 10% Super Priority Notes due 2013 effective October 8, 2012.
